I-AM Volunteer Contract

By signing this contract, I am indicating that I am committed to participate; as a volunteer in the I-AM Intermountain Advanced Ministry Program and I am committing to obtain the funds necessary to do so. I acknowledge that I will be responsible for raising money required for training, and funds necessary for my mission trip including travel, lodging, food, and a portion of the mission trip ministry supplies. This cost will be dependent on the specific mission trip I am assigned and the estimated expenses for travel and lodging while on the event.

I agree to pay a deposit in the amount of \$100.00 to the I-AM Program. This deposit guarantees a position on an I-AM team. This deposit will be refunded to me at the time of my mission trip and applied to the total cost for the trip. If I fail to complete my obligation by participating in the assigned mission trip this \$100.00 will be non refundable to me or my family.

I realize that all checks should be made out to Northwest District LCMS for I-AM Ministry (participant name) and sent to Fran Petersen at 1738 Citrus Ave. Richland WA, 99352. All moneys will be administered as a personal "support account" set up in my name on the books of I-AM. I understand that this account will be established with the submission of my initial \$100.00 deposit.

As I participate in this program, the training and mission trip costs established by I-AM and the amount of any expenses incurred by I-AM to provide for my mission trip travel or lodging, ministry supplies, and other arrangements will be deducted from my account. I must raise the funds for the remaining trip costs (after the \$100.00 deposit) and have them sent to the Fran Petersen for my I-AM "support account" at least 30 days prior to the departure date.

In the event I do not participate in I-AM, any charges incurred for me or on my behalf (airline fees, cancellation fees, deposits, etc.) will be deducted from my account, and I will be responsible for any deficit. I will pay the deficit within fifteen days following notice to me of that amount of such amount. Gifts to I-AM become the sole property of I-AM and will be administered through the LCMS Northwest District. In the event I do not participate in this ministry by not completing the training and mission activity assigned, gifts made on my behalf in my "support account" will be used to support other I-AM ministry activities. After one year, any remaining amount in my account will become the property of I-AM, and all records of my account may be discarded. In the event that funds raised exceed trip costs such excess funds will be used to cover other I-AM ministry activities.

I am a Christian and believe that the Bible commands Christians to make every effort to live at peace and to resolve disputes with one another in private or within the Christian Church (Matthew 18:15-20; 1 Corinthians 6:1-8) Therefore, I agree to participate in I-AM in a manner that reflects Christ. I commit to serve others, forgive as necessary, pray always, and respect those I encounter as I participate in this ministry. I am willing to joyfully go and "make disciples" in His name.
